Mayor Higdem called the St Thomas City Council meeting to order. Council members present Christinson, Samdahl, and Ganssle. Gunderson and Larson absent.

IT WAS MOVED by Ganssle, seconded by Christinson and carried unanimously to approve the September minutes as read. IT WAS MOVED by Christinson, seconded by Ganssle and carried unanimously to approve the October bills for payment. There was a question regarding the Rural Development Finance bill which is the yearly loan repayment for the water tower. IT WAS MOVED by Ganssle, seconded by Christinson and carried unanimously to approve the September's financial statement with an explanation on the highway expense for \$1591.95- these invoices were approved at the September meeting- Kringstads and Schumacher & Sons.

IT WAS MOVED by Samdahl, seconded by Christinson to accept the resignation of the Anita Beachamp, as the city assessor. Roll call vote: Yes: Christinson, Ganssle and Samdahl. Motion carried unanimously.

The city cemetery plot fees were discussed. It was agreed to table action on the condemnation of the houses till the next meeting or to hold a special meeting. Refuse Disposal will be contacted to see what the cost would be to have the three trailers from the trailer part put into the dumpsters. Samdahl will talk to the commissioners to see who is responsible if the property is taken from taxes.

IT WAS MOVED by Ganssle, seconded by Christinson to have a city roll off container on October 30th. Christinson will check on the scrap metal dumpster. Roll Call vote: Yes: Christinson, Ganssle and Samdahl. Motion carried unanimously.

No further business, IT WAS MOVED by Christinson, seconded by Samdahl and carried to adjourn meeting.
